For non-degree-seeking students

Our Career & Technical Award (CTA):

- Is for students in non-degree-seeking programs, classes or trainings (must apply before program begins)
- Can also pay for tests, including LSAT, MCAT, GRE and GMAT
- Covers the actual course and/or testing cost (up to \$7,200 total)
- Is awarded year-round
- Is awarded on a first-come, first-served basis
- Students are eligible to receive multiple awards, up to \$7,200 per calendar year

Who is eligible for a CTA?

CTA applicants must:

- Be enrolled to Doyon, Limited or be the child of an original enrollee
- Be enrolled in a non-degree-seeking program, course or training
- Apply for the award before their program begins.
- Provide proof of academic enrollment, such as letter of acceptance
- Have a minimum GPA of 2.0 or provide certificate of completion with passing grade

What are non-degree-seeking programs?

Non-degree-seeking programs cover a wide range of areas, including real estate, leadership, CDL, maritime, continuing education and much more. These kinds of programs include certifications, trainings, licenses and even testing fees for the LSAT, MCAT, GRE and GMAT. If you have questions about eligible programs, please get in touch!

In a degree-seeking program?

If you are an eligible student in a degree-seeking program, check out our Part-Time, Full-Time and Competitive Awards! We also offer a High School Award for high school students taking college credit.

How do I apply?

The application process for non-degree-seeking students is the same as all other Foundation students. Applications are accepted online through the Foundation's scholarship portal at doyonfoundation.com/apply. Note that first-time applicants will need to create a new account, and that it can take up to three business days to verify a student's shareholder status.

What do I need to apply?

For the CTA, applicants must submit:

- Completed online application
- Signed release and consent form
- Transcripts from the last school attended or GED scores
- Proof of academic enrollment (must show enrollment, cost of the course/training and credits received)



When is the application deadline?

Unlike our Part-Time, Full-Time and Competitive Awards, which have set deadlines, students can apply anytime during the year for a CTA. These scholarships are awarded year-round on a first-come, first-served basis, and students are eligible to receive multiple awards per calendar year, up to \$7,200 total.
